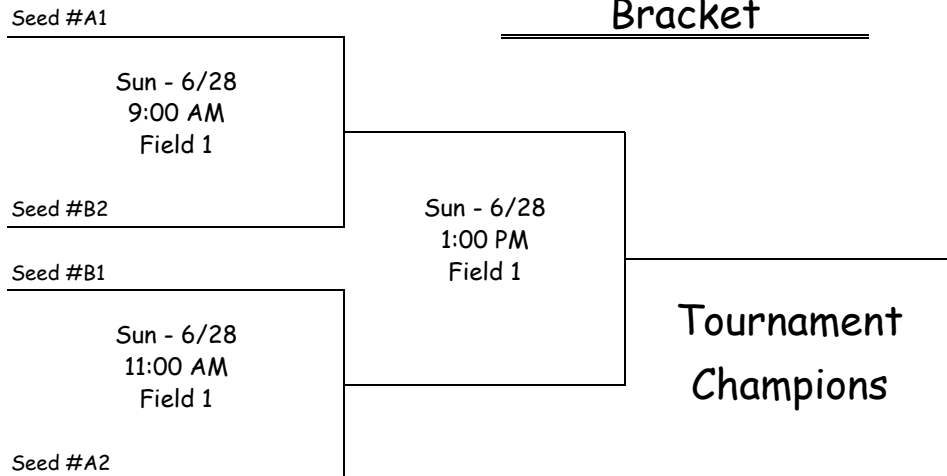

Tournament Rules

- Round-robin format for seeding into the Championship Bracket.
 - Only the top 2 seeds in each pool will advance to the Championship Game.
 - Pool-play games can end in a tie.
 - Ties count as 1/2 win and 1/2 loss.
- Bracket seeding will be determined by:
 - Best record; if tied, then
 - Head to head record; if tied, then
 - Fewest Runs allowed; if tied, then
 - Coin flip.
- Coin flip for Home team in all the Championship Bracket games.
- Regulation game length - 7 innings.
 - No inning can begin after 90 minutes have elapsed.
 - If time remains after regulation, the International Tie-breaker will apply.
- "Mercy" rule will apply per PONY Rule 5, Section 4.
